
Declaration

Netaji Mahavidyalaya (NM), Arambagh and Aghorekamini Prakashchandra Mahavidyalaya (AKPCM), Bengai, both affiliated to The University of Burdwan, linked by common academic interests, wish to initiate collaborations and exchanges in fields of shared interest and expertise in different disciplines through various programmes supported by the two colleges. Both NM & AKPCM recognise their strengths and their mutual interest in engaging themselves in Academic, Social & Cultural co-operation. The activities undertaken pursuant to this Memorandum of Understanding (MoU) are based on a spirit of cooperation and reciprocity that is intended to be of mutual benefit to both the institutions.

1. Purpose:

This Memorandum of Understanding (MoU) serves as a written understanding of agreed upon principles between NM & AKPCM concerning a set of general academic objectives. This is a non-binding agreement and is intended to clarify the nature and extent of the harmonizing activities that might be undertaken for the mutual benefit of the two institutions. Each institution will be responsible for managing its own expenses and also sharing the same when necessary. Commitments of specific institutional resources, personnel, space, facilities, or any other academic or intellectual activities considered hereunder may or may not be beyond the scope of this MoU. To the extent that the implementation of any agreed upon activity requires a commitment of resources, personnel, credit-bearing coursework, or intellectual property, a supplementary agreement will be negotiated and approved by the two parties before work on any of the projects can commence.

2. Objectives, Scope, and Major Activities:

The goal of this co-operation is to encourage and foster collaboration, provide opportunity for inter college exchange of experience and to facilitate advancement of knowledge on the basis of reciprocity, best efforts and frequent interactions to promote mutual benefits of both the institutions.

Both the institutions agree to encourage their mutual development by exploring the possibility of engaging the following modes of collaborations.

- Visits and formal exchanges of faculty, scholars and administrators in specific areas of education, research and outreach respectively.
- Explore the possibility of training through library as well as laboratory resources.
- Organize joint conferences, symposia, workshop or other scientific meeting on subjects of mutual interest.
- Exchange of academic information and learning materials.
- Organise cultural and games competitions jointly and exchange students efficient in these spheres.
- Explore the possibilities for developing joint research programs and collaborations.
- Other exchange and cooperation programs such as extension activities to which both institution agree.

3. Responsibilities of the Institutions:

The two institutions identify that the execution of any agreed upon activity will depend upon the interests and expertise of the individuals involved and availability of financial resources, space and other resources. Accordingly, the functioning of any exchange and cooperative program based on this MoU shall be conferred and determined between the two institutions. It is further expected that both institutions will be compliant with all applicable Government of India and State legislations and University policies.

4. Duration and Option to Amend, Extend or Terminate:

This MoU will become effective from the date it is signed by the authorities of both the institutions. The agreement will remain in effect for five years from the date of signature given below, and may be renewed or

amended by mutual agreement of the institutions. The institutions should agree to periodically review the activities undertaken and the progress made and to consult concerning amendments, renewal or termination of this MoU. Either authority may terminate this MoU at any time by providing written notice of such termination to the other authority, at least 3 months in advance. Once terminated, neither institutions will be responsible for any losses financial or otherwise, which the other institution may suffer. However, both the institutions will ensure that all the activities in progress are allowed to complete successfully before termination.

5. General Terms:

This MoU is not intended to and does not create any right, benefit, or trust responsibility, substantive or procedural, enforceable at law or equity, by either party, its officers, employees, or agents against the other party, its officers, employees, or agents. Nothing in this MoU obligates either party to commit or transfer any funds, assets, or other resources in support of projects or activities between the two parties. Neither party will use the name of the other, either expressly or by implication, in any publicity, solicitation or advertisement without written approval of the other party to this MoU.

6. Arbitration clause:

If there be any dispute relating to any aspect of academic and cultural co-operation, Principal/TIC of both the colleges will jointly resolve the dispute in a spirit of independence, mutual respect and shared responsibility.



Article 6





Hooghly Women's College is a Government-aided, UGC Recognized, Women's arts and Sciences College, affiliated to Burdwan University. It is located in the Hooghly district of West Bengal, India. It is the first women's college of the district. During inception of the college, classes of first year started on 1st August, 1949 with 41 students and 4 teachers. The Main building started functioning in 1952. Presently, the institution has 9 departments in Humanities and 8 departments in Science. The curriculum offered by the college allows the students to get exposed to cross-cutting issues covering a range of topics on professional skill development, Equal Opportunity Cell, Science Cell, Career counseling among other things. All the science departments are equipped with adequate instruments in the laboratories. There is a central library which abounds in rare and good books besides reading room facility and seminar library for each department.

Netaji Mahavidyalaya

The history of this college goes back to the period of India's independence. It was in 1948 that the college was established. For the first 9 years, however, it is affiliated to the Calcutta University as an intermediate college. In 1957, the college was upgraded to a degree college. In 1960, the year of foundation of the University of Burdwan, this college was affiliated to this varsity. Since then, with a gradual march the college has assumed its present status. Whereas in 1948, it started with only 96 students, its present roll strength is nearly 5747 having as many as 21 honours Departments. Besides, the college offers the facility of studying some rare courses like Plant Protection, Electronic Science, Physical Education and Six months' certificate course in Joga. It is noteworthy to mention in this context that the Dept. of Bengali has been running Post Graduation Programme since 2008. Moreover, there are two distance education centers-IGNOU and NSOU. Students from different walks of life come to these Study Centers and get Certificate, Diploma, Under-graduate and Post-graduate degrees in different subjects. The College underwent reaccreditation (Second Cycle) by NAAC in 2015.

Each party shall review the status of the MOU at least three months before the end of the five-year period to determine whether it wishes the MOU to continue and, if so, any modifications that might be necessary. The period of validity of this MOU only be extended by the mutual written consent of both parties.
8. This MOU may, at any time during its period of validity be terminated by one of the parties upon prior notice to the other in writing not later than 6 months before the termination date.
9. The parties may disclose certain confidential information to the other in relation to any future proposal made under this MOU. Each party therefore agrees that the contents of this MOU and the negotiations in relation to any future proposal may remain strictly confidential and each party hereby undertakes not to disclose the same to any third party, save for its professional advisors, without the prior written consent of the other party except where such disclosure is required by law (including without limitation, under application freedom of information legislation).

A memorandum of understanding between Netaji Mahavidyalaya, Arambagh, Hooghly, West Bengal-712601 represented by Dr. Biswanath Garai, Vice-Principal of the college and Arambagh Prochesta a registered NGO (Registration No. S0012809 of 2020-21) represented by the President, Santu Bhaluk was signed on **18th November, 2021**.

A. Objectives:

The purpose of this MOU is to establish a framework for collaboration between the College and NGO and to achieve mutual goals and objectives in the fields of education, community development, and social welfare. Netaji Mahavidyalaya (College) and Arambagh Prochesta (NGO) agrees:

- a) Jointly arrange and organize lectures, debates, discussions, seminars and excursions for the diffusion of knowledge and advancement of human civilization.
- b) To promote awareness about environment and to arrange tree plantation in the localities to combat pollutions and beautification of public places, road sides etc. jointly.

- c) To promote and encourage advancement of literacy, cultural, spiritual and scientific education jointly.
- d) To open, organize and manage charitable dispensaries, first aid center, blood donation camps from time to time and to generate awareness among people regarding thalassemia, cancer and HIV / AIDS , STD, TB etc. jointly.
- e) To arrange for medical treatment to the distressed people and those who are physically challenged by rendering qualified doctors, medicines and other allied articles free of cost jointly.
- f) To impart and develop social awareness among the illiterate women and men by organizing health awareness camps from time to time jointly.
- g) Jointly organize, manage and set up for programme and courses on water quality management.
- h) Jointly, to help, promote and organize Self Help Group (SHG) based programme for augmentation of the livelihood opportunities of the people at the grass root level as being beneficial to the public and society.
- i) To facilitate and assist the needy & poor students of all communities for the progress of studies jointly.
- j) Jointly arrange and organize old-age-home to help the needy people of the society without profit motive.
- k) To establish and maintain the basic and adult education centers to remove illiteracy jointly.
- l) To render relief to the victims of suffering in time of famine, flood, drought, earthquake, cyclones, and other natural calamities jointly.

B) Terms and Conditions

Both the parties named above agreed to abide by the terms and conditions detailed below under which the College and the NGO will work together.

- i) College students, NSS volunteers of the College, accompanied by faculty members will participate in the welfare programmes organized by the NGO.
- ii) The NGO will assist the College students in conducting welfare activities in a particular underdeveloped area, a village or community that is adopted by the College.
- iii) Programmes to be undertaken will always be need-based and of mutual interest.
- iv) The NGO will inform to the in charge of the college about the commencement of any programme of mutual interest well in advance so that the students of the college get enough time for preparation.
- v) A letter from Principal/Vice-Principal/TIC with the details of the participating students and the faculty member will reach the NGO office in well advance before the commencement of the programme.

vi) **Coordination:** Each organization shall appoint one/two member to coordinate the programme on its behalf. Further, a coordination committee, consisting of (a) Secretary, NGO or his/her Nominee from the side of Arambagh Prochesta and (b) Principal/ Vice-Principal/TIC, Netaji Mahavidyalaya or his/her Nominee

vii) **Tenure and Termination:** This MOU will be effective on and from **18/11/2021** and it is signed by representatives of the two institutions. It will remain valid for three years, and may be continued thereafter after suitable review and agreement. Either organization may terminate the MoU by giving written notice to the other institution six months in advance. Once terminated, neither Netaji Mahavidyalaya nor Arambagh Prochesta will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, Netaji Mahavidyalaya and Arambagh Prochesta will ensure that all activities in progress are allowed to complete successfully.



Background:

Government of India decided to undertake Testing and subsequent Monitoring & Surveillance of all public drinking water sources, at least once a year for the present, in order to assess the total scenario of water quality and enable to take suitable measures to improve the same, where required, in order to minimise the health hazards of the people caused by consuming unsafe water. This shall in turn lead to a healthy society with minimum expenditure for treating the ailment, caused by water related diseases. Such an endeavour shall also help in identifying vulnerable sources of contamination by improper sanitary and waste-water management practices, which shall be an indicator to go for better sanitational and waste water discharge / disposal scenario.

The Govt. of West Bengal, in convergence with few related departments, notable organisations and institutes, have decided to undertake the programme, through a network of water of testing laboratories spread throughout the state. Such an infrastructure is already

existing (and being strengthened further), which mainly has two categories of Laboratories. One category is PHED's own laboratories and the other being NGO managed (but controlled by WB PHED) laboratories. The guidelines for functioning of such laboratories have already been finalised.


For the NGO managed laboratories, an agreement has been decided to be executed which entails proper functioning of the laboratories and other relevant aspects, in order to carry forward the functional programme, effectively and purposefully.

Scope of Agreement:

The agreement is made for the duties, responsibilities and related financial matters of the NGO managed laboratory and State of West Bengal. The validity of the agreement shall terminate only at the instance of consensus of either party. The agreement remains open for further modification, as and when required, with annexure agreements.

Duties and Responsibilities of NGO's who shall manage the laboratory:

1. To ensure sufficient transparency in functioning and financial matters.
2. To engage and obtain service of qualified personnel to carry out the water testing works. The Chemists, Bacteriologists, Laboratory Assistants and other categories of workers should have adequate Educational Qualification and experience. The details of such personnel with their photograph and other antecedental records are to be furnished to respective Executive Engineer of PHED and approval be obtained. In case of any change of personnel due to reason of inefficiency or any other ground, similar informations to be informed in writing to the said offices of PHED.
3. To ensure regular and proper payment of salaries, bonus etc. to all workers for which few rates are suggested, for the present, as below:
 - i) Chemists – Rs. ^{6000/-}4000/- per month.
 - ii) Bacteriologists – Rs. ^{6000/-}4000/- per month.
 - iii) Laboratory Assistant – Rs. ^{4000/-}2500/- per month.
 - iv) Other Categories – Reasonable.
4. To undertake all data processing, recordings and documentation through computers and in hard copies and dissimination of the records and reports through computers (on line facility) and/or through signed statements on papers. This activity to be assigned to any of the existing staff.
5. To make regular payment of electricity bills, telephone bills, internet connectivity and other related activity bills etc. The default and its consequences shall entirely be on the NGO.
6. To make expenditures for making guarding, approach to laboratory, stable encompassment of the campus of the area with boundary walls, gates, drains etc.

7. To ensure that the laboratory building has sufficient working space for installing equipments, gadgets, storing space for chemicals, reagents, glasswares etc., well ventilation and exhaust system for expulsion of fumes, lavatory blocks for workers (both for ladies and gents separately) coupled with septic tanks and soak pits, proper plumbing and sewerage lines with apertenances and fittings, sufficient available water with a storage tank at the roof top, proper and adequate electrical wiring with lights, fans, switches, plug points, main switch etc., adequate numbers of filled and updated fire extinguishers including periodical refilling and checking for its proper functioning and all other required safety devises etc. All expenses on these scores to be borne by the NGO.
8. To ensure maintenance of the laboratory buildings with periodical colour washing, painting, replacement of damaged parts and fixtures etc. All expenditures on this score to be borne by the NGO.
9. To ensure periodical repair of all machines and equipments, performance of Annual Maintenance Contracts with reputed organisations, in order to keep all the equipments in functional mode. Expenditures on this account to be borne by NGO. Insurance coverage, if any, to be made by the NGO at their own cost.
10. To ensure regular payment of all sorts of civil amenity taxes, as applicable, for the laboratory building and the related properties.
11. To ensure timely replacement of broken / damaged and irreplaceable glasswares, plastic wares, furnitures, refrigerators etc. at the cost of the NGO.
12. To issue identity cards to every employee of the laboratory, duly counter signed by concerned Executive Engineer of PHED. The card should clearly depict the name, designation, name of the laboratory, address of the employee, permanent identification mark, signature of the employee, and signature with seal of the NGO (issuing authority). The card to be immediately collected back at the event when the employee is discontinued due to any reason, with notice to all concerned forthwith. Any default on this aspect shall make the NGO responsible.
13. To ensure timely flow of all stationeries for computers e.g. inks of the printers, papers, registers, pens, pencils, scales, clips, file covers, guard files etc., at the cost of the NGO.
14. To ensure the capacity of testing of around twenty samples in a day (for the present), on following parameters is achieved and maintained.
 - pH,
 - Hardness,
 - Iron,
 - Arsenic / fluoride / chloride (in susceptible areas)
 - Bacteriological Quality.
 - Any one / two more parameters, if so directed, on specific instances.

The method of testing shall be governed by "STANDARD PROCEDURES, GUIDELINES AND PROTOCOL", to be provided by PHED.

The laboratories to work on all working days (except Sundays and gazetted holidays) normally. But under specific orders of PHED, the laboratories may have to work on Sundays and holidays, in exigencies.

15. To ensure provision of receipt of acknowledgement against availability of samples, handing over of reports, all funds received and expenditures made vis-à-vis no. of samples tested.

16. To ensure inspection and checking of all facilities, functioning, reports and financial transaction records by authorised officials of WB PHED, P & RDD, H & FWD and other authorities, wherever required.

17. Submission of requirement of chemicals and reagents, well in advance, to PHED, periodically. 18. To ensure that the publication of any test result without the consent of the Deptt. will be punishable offence as per norms as well as termination of agreement.

Roles and Responsibilities of Different Govt. Departments in Relation to the NGO's of Laboratories:

A) PHED:

1. Over all monitoring of functioning of laboratory.
2. Scrutiny of framed-out schedule of working upon availability of samples from each G.P. (detailed schedule by CCDU) and its subsequent changes, if any.
3. Initial up gradation of laboratories by providing additional equipments, chemicals, reagents, glass and plastic wares etc.
4. Fulfilment of requirement of chemicals as per indent, periodically.
5. Settle disputes arising out of any genuine reasons and verdict shall be final and binding to NGO.
6. Arrange for cross checking of samples from State Referral Institutes.
7. Organising training / refresher courses of technicians of NGO laboratories.
8. Obtain test results data through linkage from the laboratories and insertion in departmental website.

B) P & RDD:

1. Providing testing charges @ Rs.50/- per sample to each NGO laboratory and Rs.25/- to facilitator for sample collection and report submission through funds being made available to respective Zilla Parishad / Panchayat Samity / Gram Panchayat network.
2. Inspection of activities and functioning of laboratories including checking of data and records and other relevant documents at the NGO laboratories.
3. Arrangement of engagement of G.P. wise Facilitators with instruction to acquaint with concerned NGO laboratory workers / owners.



The goal of this co-operation is to encourage and foster collaboration, provide opportunity for inter college exchange of experience and to facilitate advancement of knowledge on the basis of reciprocity, best efforts and frequent interactions to promote mutual benefits of both the institutions.

Both the institutions agree to encourage their mutual development by exploring the possibility of engaging in the following modes of collaborations.

- Visits and formal exchanges of faculty, scholars and administrators in specific areas of education, research and outreach respectively.
- Explore the possibility of training through library as well as laboratory resources.
- Organize joint conferences, symposia, workshop or other scientific meeting on subjects of mutual interest.

3. Responsibilities of the Institutions:

The two institutions identify that the execution of any agreed upon activity will depend upon the interests and expertise of the individuals involved and availability of financial resources, space and other resources. Accordingly, the functioning of any exchange and cooperative program based on this MOU shall be conferred and determined between the two institutions. It is also expected that both the institutions will work at par with all the applicable policies of the Govt. of India, State Govt. and University legislations.


4. Duration and Option to Amend, Extend or Terminate:

This MOU will become effective from the date on which it is signed by the authorities of both the institutions. However, both the institutions will ensure that all the activities in progress be allowed to complete successfully before termination.

This MoU is not intended to and does not create any right, benefit, or trust responsibility, substantive or procedural, enforceable at law or equity, by either party, its officers, employees, or agents against the other party, its officers, employees, or agents. Nothing in this MOU obligates either party to commit or transfer any funds, assets, or other resources in support of projects or activities between the two parties. Neither party will use the name of the other, either expressly or by implication, in any publicity, solicitation or advertisement without written approval of the other party to this MOU.




6. Arbitration clause:
